Adding new fields to your Veeva OpenData subscription

When Veeva OpenData adds new fields to a country that you are subscribed to, you can add the field to the subscription so that it's ready to receive data and be managed by Veeva OpenData.

Enabling Veeva OpenData fields for extended use

Veeva OpenData fields can be enabled to load local data or third party data. A field can be managed by Veeva in some countries, managed by a third party source in other countries, or be owned by a customer in the remaining countries.

Administrators can view ownership of the data model fields, by country, in the Network user interface by navigating to **Data Model** and choosing the **Customer Master** data domain. Click **Export Data Model** or select an object to view specific field details.

Field updates for all countries

Veeva ID

The **Veeva ID** CDA field (`veevaid__v`) is now enabled by default in all Network instances. This field is the global identifier from Veeva data products and is part of the Common Data Architecture (CDA) data model.

This system field is enabled, even if the CDA data model is not enabled, so all customers and downstream systems have access to this Veeva-wide ID.

Supported countries

The Veeva ID is enabled for OpenData countries where CDA is supported. CDA is not supported for China, Hong Kong, Japan, and Macao.
